CLASSIFICATION OF PROPERTY

For ad valorem tax purposes, property is classified as follows:

Class I (NO LONGER TAXABLE)

All tangible personal property employed exclusively in agriculture, including horticulture and grazing; all products of agriculture, including livestock, while owned by the producer; all notes, bonds, bills and accounts receivable, stocks and any other intangible personal property.

Class II

All property owned, used and occupied by the owner exclusively for residential purposes; all farms, including land used for horticulture and grazing, occupied and cultivated by their owners or bona fide tenants.

Class III

All real and personal property situated outside of municipalities, exclusive of Classes I and II.

Class IV

All real and personal property situated inside of municipalities, exclusive of Classes I and II.

Total levy rates by class vary between counties. The rate of Class II property is two times that of Class I and the rates of Classes III and IV property are four times that of Class I.

GUIDE TO COUNTY, SCHOOL, AND MUNICIPAL LEVY RATES (ALL RATES OF LEVY IN CENTS PER \$100 VALUATION)

Rural Rates

Rates levied by State, County, and Board of Education.

State Current

Rates for State Current are .25 for Class 1; .50 for Class 2, and 1.00 for Class 3 and 4 set by West Virginia State Code.

County Current

County Current - Maximum for Class 1 is 14.3, Class 2 is 28.6, Class 3 and 4 is 57.2.

County Bonds

Rate is determined by amount of money that must be raised to pay the principal and interest on the bond. Total Bond Rate and County Current may not exceed the maximum rates of 14.3, 28.6, and 57.2.

County Excess Levy

May be imposed for up to 5 years if such levy is approved by 60% of the voters in a levy election. Maximum rates are 7.15 for Class 1, 14.3 for Class 2 and 28.6 for Classes 3 and 4.

Public Improvement

Total of County Current, Bond and Public Improvements may not exceed maximum levy rates stated in #2, above.

Maximum Rate for County

Current, Bond, Excess Levy and Public Improvement rates may not exceed 21.45 for Class 1, 42.9 for Class 2, and 85.8 for Classes 3 and 4.

School Current

Maximum rates are 22.95 for Class 1, 45.9 for Class 2, and 91.8 for Classes 3 and 4.

School Bonds

Rate is determined by amount of money that must be raised to pay the principal and interest on the bond. Rate is in addition to the School Current Rate.

School Excess Levy

May be imposed for up to 5 years if such a levy is approved by a majority of the voters in a levy election. Maximum rates are 22.95 for Class I, 45.9 for Class 2, and 91.8 for Classes 3 and 4.

Permanent Improvements

Total School Current and Permanent Improvement rates may not exceed maximum rates of 22.95, 45.9, and 91.8.

Total Rural Rate (State, County, and School)

Rate to be charged for taxes on property located in rural districts (outside a municipality).

GUIDE TO COUNTY, SCHOOL, AND MUNICIPAL LEVY RATES (ALL RATES OF LEVY IN CENTS PER \$100 VALUATION)

Municipal Current

Maximum rates are 12.5 for Class 1, 25 for Class 2, and 50 for Class 4.

Municipal Bonds

Rates determined by amount of money that must be raised to pay the principal and interest on the bond. Total Bond and Municipal Current may not exceed maximum rates of 12.5, 25, and 50.

Municipal Excess Levy

May be imposed for up to 5 years if such a levy is approved by 60% of the voters in a levy election. Maximum rates are 6.25 for Class 1, 12.5 for Class 2, and 25 for Class 4.

Maximum Rate for Municipality

Current, Bond, and Excess Levy may not exceed 18.75 for Class 1, 37.5 for Class 2, and 75.0 for Class 4.

Total Rural and Municipal Rates

Rate to be charged for taxes on property located inside a municipality.
