Recognizing the presence of a quorum, Jeff Amburgey called the meeting to order at 2:10 p.m.

The purpose of this meeting was to review and discuss the Natural Resource and Industrial Property Appraisal 3-Year Monitoring Plans.

# 1. <u>Industrial and Natural Resource Property Appraisal Plans for 2019, 2020 and 2021</u>

Jeff Amburgey explained that statutorily the PVC must approve the 3-year plans for Industrial and Natural Resource property. He further explained that the county assessors each must submit a 3-year plan for the properties they assess. These plans are approved by the State Tax Department.

## **Industrial Property Plan**

Leroy Barker discussed the changes made since the last 3-year plan (namely the parcel counts and staffing). As there were some accounts that were commercial and not industrial, the number of accounts is less in this 3-year plan as the Tax Department made a concerted effort to no longer appraise these taxpayers but return them to the county assessors for processing.

Eddie Young made a motion to accept the Industrial 3-Year Plan. Drema Evans seconded the motion. With no further discussion and all members voting in favor, the motion carried.

## Natural Resource Property Plan

Jeff Amburgey discussed the changes made since the last 3-year plan (namely the parcel counts and staffing). The biggest change in parcel count was the addition of new oil and gas wells over the 3-year period. With respect to staffing, the Tax Department no longer has field mappers.

Mickey Brown made a motion to accept the Natural Resource 3-Year Plan. Eddie Young seconded the motion. With no further discussion and all members voting in favor, the motion carried.

### • Budget Revision Review for Final Approval

A FY2017-18 budget revision for Tyler County was presented for final approval.

Drema Evans moved to approve the budget revision. Kurt Donaldson seconded the motion. With no further discussion and all members voting in favor, the motion carried.
